The Government of China wishes to make the following reply:

The Chinese public security authorities are ensuring the right to personal freedom and to freedom of expression of Wang Qiaolin and Li Wenzu, in accordance with the law, and have taken no measures of any kind against them. There has, for instance, been no intimidation, harassment or unlawful surveillance such as that mentioned in the joint urgent appeal of the Human Rights Council special mechanisms.
